I will not enter nor attempt to enter the cages of any of the animals unless asked to do so by a staff member.

I will willingly take no action that will cause damage of any kind to the property.

I understand and agree that unless agreed to in writing, all of my services and/or time spent with The Catty Shack Ranch is on a volunteer basis and will not be compensated in money or in any other way by The Catty Shack Ranch.

I understand that unless previously agreed to, all expenses related to my volunteer service with The Catty Shack Ranch, will be absorbed by me, and I will not be entitled to any expense reimbursement.

If I violate any of these covenants and /or any other covenants that I agree to in writing which results in legal costs to The Catty Shack Ranch, I hereby agree that I will be solely responsible for these costs.

If for any reason The Catty Shack Ranch has to pursue legal recourse against me, and is granted a monetary judgment, I waive my legal right to offset this debt through bankruptcy proceedings.

All of the information provided above is true and correct and I have withheld no information which could result in injury to any animal and/or volunteer on the property of The Catty Shack Ranch.
